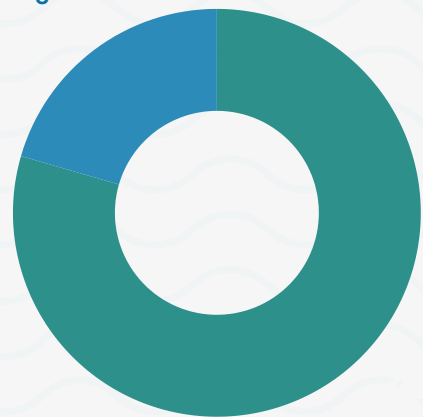

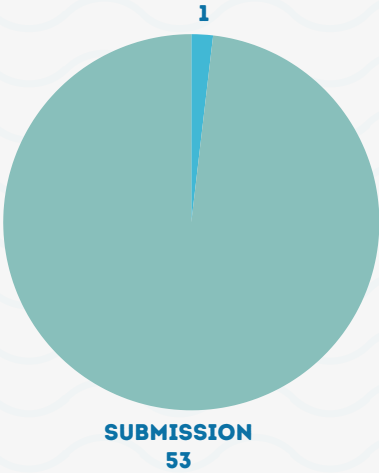

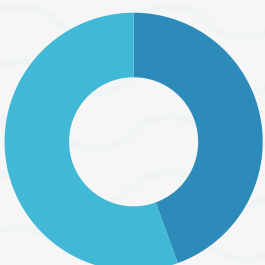

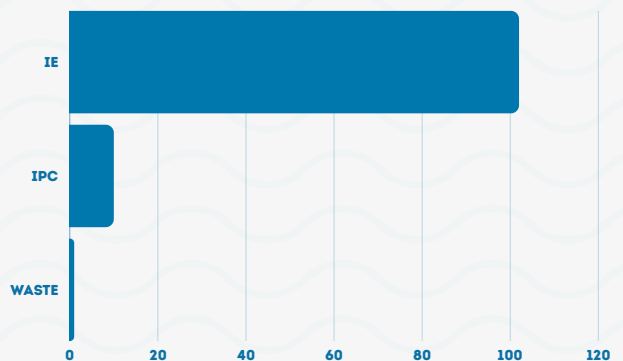

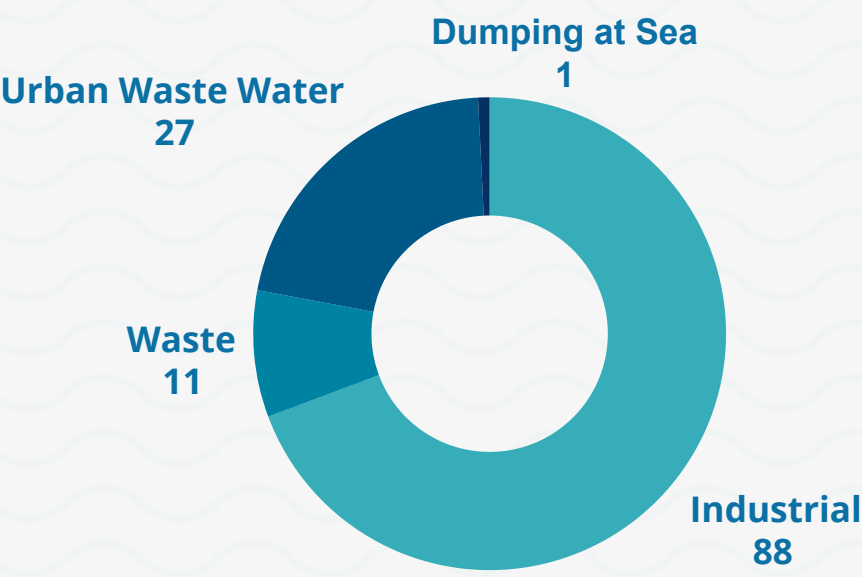

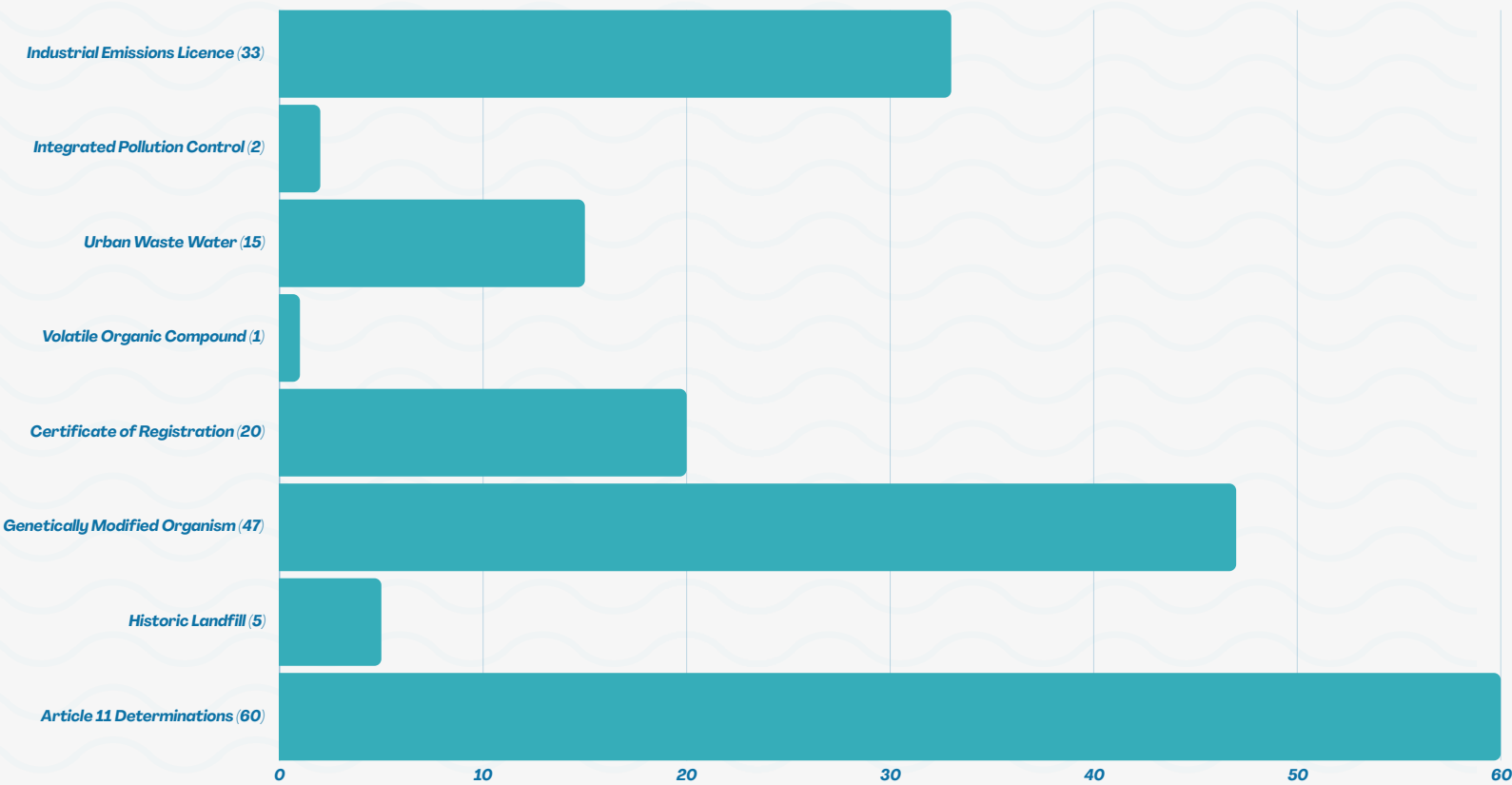

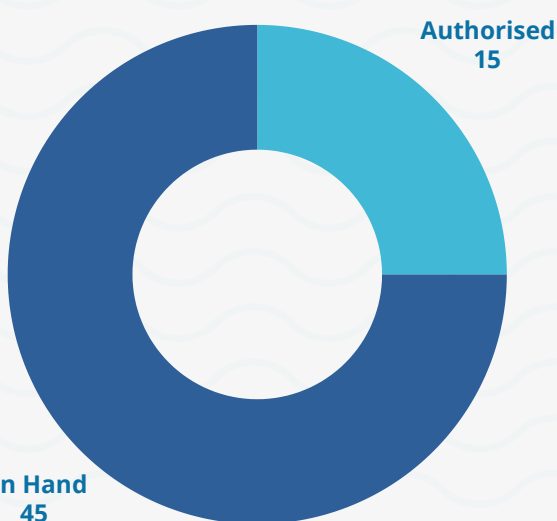

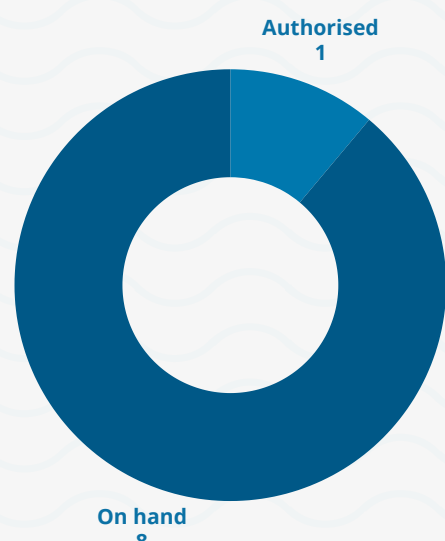
TOTAL AUTHORISATIONS ISSUED IN 2024
