Guidance for Application Fees payable for IE, IPC and Waste License Applications

An application fee is applicable to all IE, IPC and Waste licence applications submitted to the EPA. Once an application has been accepted, the Agency will then review the fees payable for the activities associated with the application.

The fees payable under the EPA Act/Waste Management Act are set out below:

1. IE/IPC Classes of Activity as per the First Schedule of the EPA Act, 1992 as amended (excluding IE Classes 11.2 -11.7)

Appendix 1 provides a breakdown of Fees for an Activity or Class of Activity in the First Schedule of the EPA Act 1992, as amended. *Note this excludes Class* 11.2 - 11.7

- a. A fee is payable for *each individual activity* as set out in Appendix 1
- b. Justification should be provided by the licensee indicating whether the activity is considered small or large.

Note – A Class 11.1 activity must have a connection or association with another activity at the same licenced site and can only be an 'additional' class of activity. A Class 11.1 is any waste activity that's not covered by 11.2 – 11.7.

2. IE Classes 11.2-11.7 as per the First Schedule of the EPA Act, 1992

Appendix 2 provides a breakdown of fees for Classes 11.2 – 11.7 of the First Schedule of the EPA Act 1992, as amended.

- a. A fee is payable for an activity applied for as per Appendix 2
- b. As per Article 3 & 4 of the <u>Environmental Protection Agency (Licensing Fees) Regulations</u> 2013, where more than one activity is applied for in Appendix 2, only the *highest fee* shall be payable to the Agency
- 3. Waste Licence Activities as per the Third and Fourth Schedule of the Waste Management Act, 1996

<u>Appendix 3</u> provides a breakdown of fees for waste licence activities as set out in Articles 40 and 41 of the <u>Waste Management (Licensing) Regulations 2004</u>:

- a. A fee is payable for an activity applied for as per Appendix 3.
- b. As per Articles 40(3) and 41(3) of the Waste Management (Licensing) Regulations 2004, where more than one activity is applied for in Appendix 3, only the *highest fee shall be payable to the Agency*.

<u>Appendix 4</u> provides various scenarios to help demonstrate how to determine the application fee.

Where the application fee provided by the applicant has been deemed incorrect, the Agency shall request any outstanding fees to be submitted by the applicant via a Request for Further Information**. Failure to provide a complete application fee may result in the withdrawal or abandonment of the licence application.

A waiver or refund request may be submitted if the applicant deems the application fee not applicable to the activity related to their application.

In circumstances where the Agency refuses to grant a Class of Activity sought, the Agency may recommend a partial refund of the fees paid.
